On Saturday, October 19, 2019 the Polk County Firefighters Benevolent Fund will be hosting the first annual charity golf tournament. The golf tournament will be held at the **Bartow Golf Course** in Bartow Florida. Participation in the tournament along with all proceeds will benefit the financial wellbeing of firefighters and their families in times of need.

The mission of the Polk County Firefighters Benevolent Fund is to provide financial and emotional assistance to families of injured or fallen firefighters, firefighters, and the communities they protect. Since its formation in 2012, thousands of dollars have been used to aid in the financial facets of firefighter personnel and their families. It is not widely understood by the public on what is truly a reality in the fire service in terms of certain benefits. Firefighters are at least 14 percent more likely to develop cancer than the general public according to the National Institutes for Occupational Safety and Health as well as the National Cancer Institute- 2015 study. Firefighters are twice as likely to get skin cancer, testicular cancer, mesothelioma, lung cancer, and leukemia. Florida is among 13 states that have not passed a presumptive cancer law- a law recognizing that a firefighter's disability or death from cancer is presumed to be contracted in the line of duty. Cancer is the second leading cause of death among firefighters today following cardiovascular disease. This as many may know can weigh a heavy financial burden while receiving no financial benefits. Until this law is changed to help improve financial and medical benefit opportunities to firefighters, the Polk County Firefighters Benevolent Fund will continue their support.

The Polk County Firefighters Benevolent Fund is a 501(c)(3) organization which means most monetary gains are received via donations. Much of what is received is done so through donations whether to provide aid financially or to assist in covering food, clothing and other necessities in the event of a family crisis, hardship, or emergency situation. The Polk County Firefighters Benevolent Fund is the stability that firefighters, their families, and the community depend on during any unfortunate incident.
